



## European data spaces: The agricultural and agri-food data space "Gaia-X Ready" with Agdatahub

**PRESS RELEASE - Paris, November 6, 2023 – On the occasion of the 4<sup>th</sup> Gaia-X Summit to be held on November 9 and 10 in Alicante (Spain), Agdatahub, the data intermediation platform dedicated to the agricultural and agri-food sectors in France and Europe, today announced that its entire technical architecture is compliant with the *de facto* Gaia-X standard.**

### Agdatahub, a step ahead for Europe's 10 million farmers

With dozens of use cases already operational, including pesticides optimization, environmental labelling, animal genetics and carbon credits, Agdatahub ensures traceability, control and confidence over data exchanges by applying the latest *de facto* Gaia-X standard.

Today, over 2,000 users from a wide variety of organizations are connected to the platform deployed by Agdatahub to exchange data in a trusted environment. These participants benefit from advanced functionalities such as a secure digital identity wallet, a consent and authorization manager, a data catalogue, a contract manager and a data transaction orchestrator, with technologies from Dawex, Orange Business and IN Groupe.

For Agdatahub, as for the various Gaia-X members in Europe, trust is in fact a key element to enable the creation of federated data spaces stimulating the European data economy.

### Agdatahub and Gaia-X: for a Europe of data based on transparency, openness and sovereignty

Agdatahub has chosen to operate its data intermediation platform with technological services developed by recognized software publishers, guaranteeing functional upgrades to their products and the implementation of market technological and regulatory standards.

Agdatahub has therefore chosen to collaborate with technology partners who have already implemented the *de facto* Gaia-X standard: Dawex with its Data Exchange technology, and Orange Business with its trusted hosting & its clearing house which is now available in beta mode.

These implementations, presented at the Gaia-X 2023 Summit, ultimately demonstrate the interoperability of Agdatahub's data offerings' catalogue, as well as the Gaia-X conformity of participants' identities in the near future, with other platforms from agricultural institutes in Belgium or agricultural machinery in Germany.

*"The implementation of services compliant with the de facto Gaia-X standard by our technology partners Dawex and Orange Business guarantees to our customers the interoperability of their identities and data offers on other similar platforms of the future European Data Space for Agriculture, or other sector-specific data spaces such as Green Deal, Tourism or Space,"* concludes Sébastien Picardat, CEO of Agdatahub.
